North American Shipments (US, Mexico and Canada)

All collect shipments from your facility must comply with the following weight/space restrictions chart. Purchase Orders are location specific. Multiple Purchase Orders to the same Venchurs location due in the same week should be combined into one shipment. Shipments in excess of once per week to the same location must be approved in advance by your Venchurs expeditor using the AETC process outlined below. An attached packing slip must accompany each shipment.

Billing

All freight invoices need to be marked collect to Venchurs, Inc.

<u>NOTE</u>: BOL <u>must</u> include the correct NMFC Code and Freight Class. The excess cost incurred from the freight carrier due to the exclusion of this information will be charged back to your company plus an additional \$50 Administration Fee.

AETC Process:

Any deviation from the above routing instructions will require an AETC number (Authorization for Excess Transportation Charges) obtained from your Venchurs buyer. The A.E.T.C. # given must appear on any bill of Lading and Packing List associated with the shipment.

Failure to comply with the above instructions may result in excessive freight costs. The excess amount will be charged back to your company plus an additional \$50.00 Administration Fee.
